

2010 TeenScene Audition Guidelines

Please read the following guidelines carefully.

Application:

1. Applications available on the City of Lexington's website at www.lexingtonnc.net or the Robbins Recreation Center.
2. Applications can be mailed c/o Tammy Curry, TeenScene Auditions, 28 West Center Street, Lexington NC 27292 or taken to Robbins Recreation Center at 512 S. Hargrave Street, Lexington, NC 27292.
3. **All audition applications must be submitted by Monday, March 15, 2010.**
4. Applications must be completely filled with notarized waiver form attached.
5. No entrant will be allowed to participate without liability waivers signed by an adult 18, parent or legal guardian.
6. Applicants may submit a photo and promotional CD with application.

Auditions:

1. Auditions held at the Robbins Recreation Center located at 512 S. Hargrave Street, Lexington, NC 27292.
2. Auditions **Saturday, April 3, 2010** beginning at 12pm until 5pm.
3. All applicants must arrive early to check in at audition desk.
4. Be prepared to render two songs.
5. Applicants must leave the building following their auditions.
6. All vocal groups and bands selected to perform will be contacted by **Friday, April 16, 2010.**
7. TeenScene Chairperson, Lexington Youth Council, Committee Members and the Festival Planning Committee have the right reject any entry.
8. Vocal Groups and Bands selected to perform will receive an event packet.

Multicultural Festival:

1. Multicultural Festival will be held on **Saturday, May 1, 2010** at Finch Park in Lexington. Finch Park is located at 15 Paul Beck Rd, Lexington, NC 27292. The festival will begin at 10am—5pm. Committee organizers have the right to make changes to scheduled time of performances.
2. All performers chosen will meet at the TeenScene information booth for check-in.
3. All vocal groups and bands must report to designated area before performance time.
4. All vocal groups and bands must be respectful to TeenScene and festival organizers.
5. You must have permission to distribute and sell promotional items and CD's.
6. Inappropriate clothing, soundtracks or performances is prohibited.
7. **Absolutely No fowl language, drinking or drugs permitted.**
8. Any entrant using unacceptable conduct and language will be removed from the TeenScene and asked to leave the premises immediately.
9. **ONLY official event sponsors are allowed to display company names, banners and logos.**
10. Event organizers have the right to revise and add guidelines without notice.
